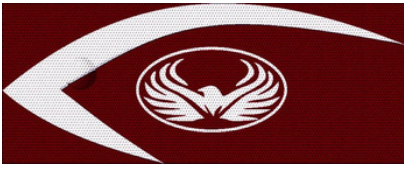

2. MAN POWER DEVELOPMENT:

HAY BRAVO SECURITY organizes training programme for various corporate organizations, individuals etc in our well-equipped Training Centre. We also provide in-house trainings and refresher courses for staff of all classes of business / non-profit organizations using our seasoned and well-trained professionals / instructors.

3. ARMED ESCORT SERVICES:

We also provide safe, secure and comfortable protocol / armed escort services for people and valuable assets from one point (source) to another (destination) within Nigeria. This aimed at providing adequate protection to persons and valuables without any hindrances.

OUR SPECIALTIES

A. FULL DAY ARMED ESCORT SERVICE: These services are either within the state or inter-state. It operates on the basis of providing armed escort for personnel and / or assets from source to destination on for a maximum period of 24 hours. 6. Further training is provided specifically to the location the guard is to be deployed and the nature of the client's business. This training, which is done in collaboration with the client, provides the guards orientation to the client's premises and the peculiar environmental risk faced by the client generally.

10. DEPLOYMENT OF PERSONNEL: After the full training is completed, the guards are then deployed to their respective beats or locations. Our policy is to deploy guards in either two shifts of twelve hours each or three shifts of eight hours each. Each guard works 6 days per week and is given 1 day off and coverage is provided by a relief guard.

THE SHIFTS ARE DISTRIBUTED AS FOLLOWS:

- * Twelve hours shift Morning 6:00am-6:00pm, night 6:00pm-6:00am.
- * Eight hours shift Morning 6:00am-2:00pm, afternoon 2:00pm-10:00pm, night 10:00pm-6:00am

11. SURVEY OPERATIONS: We have found that security protection of any given premises has its diverse technological security approach. 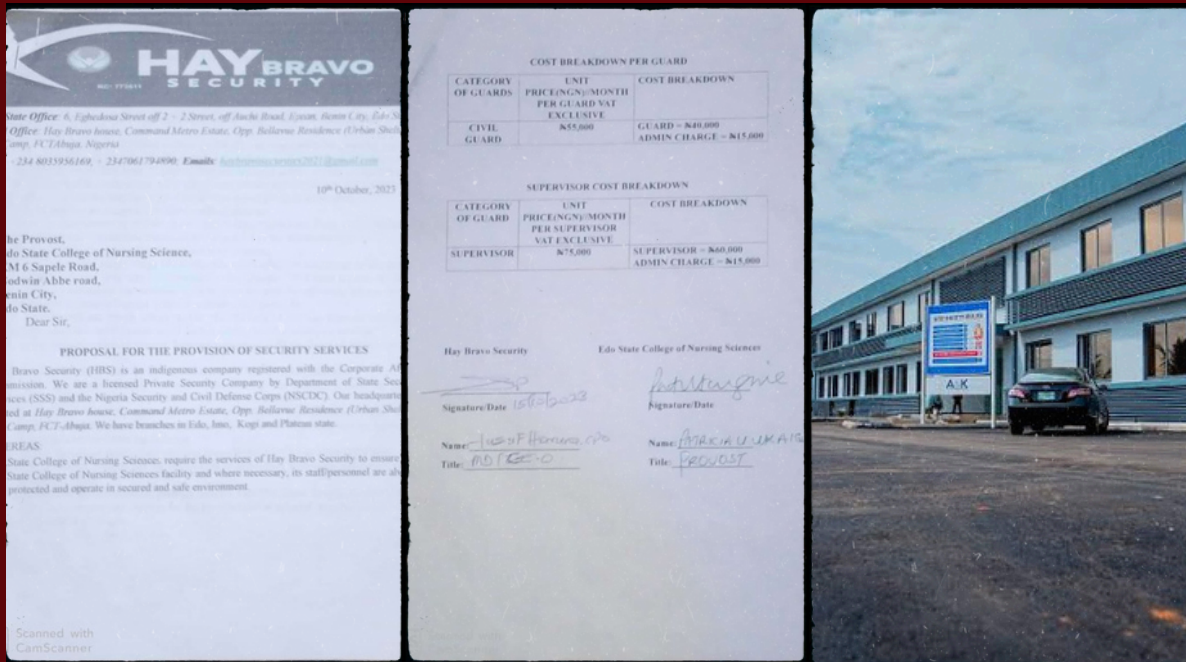


